WATER REPORT – December 6, 2022

Precipitation (PRECIP) totals received at SNOTEL sites in the Snake River Basin above Palisades Reservoir since October 1st are currently below-average at 98%. The snow-water-equivalent (SWE) currently held in the snowpack for those same sites is above-average at 128%. All other subbasins within the watershed upstream from American Falls have above-average totals for both PRECIP and SWE.

SWE percentages are currently higher than PRECIP percentages because of cold temperatures in October and November 2022 that have caused a higher percentage of precipitation to fall as snow rather than rain still held in the snowpack. Last year, much of the precipitation received in October and November 2021 fell as rain or fell as snow that subsequently melted prior to December due to warmer temperatures in that year.

The current reservoir system contents are 99,000 AF less than they were on this same date last year.


